WITH 80 CONTRACTED MUSICIANS AND AN AFFILIATED COMMUNITY CHORUS -SYMPHONY TACOMA VOICES- THE ORGANIZATION PRESENTS CLASSICAL, POPS, CHORAL AND YOUTH EDUCATION PROGRAMS IMPACTING NEARLY 20,000 CITIZENS ANNUALLY FROM THROUGHOUT THE SOUTH SOUND.
