THE ORGANIZATION WAS FOUNDED IN 1946 AND CURRENTLY HAS 80 CONTRACT MUSICIANS AND AN AFFILIATED VOLUNTEER CHORUS. SYMPHONY TACOMA'S MISSION IS "BUILDING COMMUNITY THROUGH MUSIC." WE WORK TOWARD THIS THROUGH A SEASON OF NINE CORE MASTERWORKS PERFORMANCES AND A WIDE VARIETY OF YOUTH EDUCATIONAL OFFERINGS. IN TOTAL, OUR PROGRAMMING ANNUALLY REACHES OVER 17,000 CITIZENS.
