OUR 2020-2021 WAS A FIRST IN OUR HISTORY. DUE TO THE COVID-19 PANDEMIC, ALL PERFORMANCES THROUGHOUT THE YEAR WERE VIRTUAL SINCE OUR VENUE WAS NOT OPEN. SYMPHONY TACOMA OFFERED SEVERAL DIFFERENT SERIES, INTERVIEWING NOTABLE GUEST ARTISTS AND MUSICIANS FROM ACROSS THE GLOBE, A NEW CHAMBER MUSIC SERIES SPOTLIGHTING OUR SYMPHONY TACOMA MUSICIANS AND REPLAYING PAST PERFORMANCES WHICH INCLUDED NEW VISUALS. WE EXPANDED OUR EDUCATION PROGRAMS AND PARTNERED WITH THE TACOMA YOUTH SYMPHONY TO
